Waiver and Release

Summer 2005 (June 20 - August 12)

We understand and recognize that there is always an inherent risk of bodily injury and harm associated with camping, sports, swimming, and other activities. No warranties or representations of any kind have been made by the Jewish Federation of Palm Springs and Desert Area, its employees, agents, volunteers, directors, trustees, successors or assigns regarding the activities at Camp Desert Star. Signature of this Waiver and Release means that we and our child hereby personally assume all risks in connection with our child's participation in and attendance at Camp Desert Star and in connection with participation in any and all activities of Camp Desert Star.

We waive and release the Jewish Federation of Palm Springs and Desert Area, its officers, trustees, employees and volunteers, as well as any of its sponsors and/or affiliates from any and all claims relating to our child's attendance at Camp Desert Star, or his or her participation in any activity at the Camp Desert Star, unless caused by the gross negligence or willful misconduct of any such persons. We hereby acknowledge that our child's transportation by any employee, volunteer or any other representative of the Jewish Federation of Palm Springs and Desert Area while attending Camp Desert Star is voluntary, and that such transportation is at his/her own risk. We understand and agree that neither Jewish Federation of Palm Springs and Desert Area nor any of its volunteers, officers, trustees, directors, employees or other agents or representatives may be held liable in any way for any occurrence in connection with our child's transportation which may result in injury, death or other damages of any kind to him/her or our family, estate, heirs or assigns. We hereby personally assume all risks in connection with our child's transportation by a Jewish Federation of Palm Springs and Desert Area employee or representative during the weeks of Camp Desert Star, and further release Jewish Federation of Palm Springs and Desert Area, its volunteers, officers, directors, employees or any other agents or representative for any injury, death or damage that may result to our child or our family from our child's transportation, including all risks connected there with, whether foreseen or unforeseen; and further to save or hold harmless Jewish Federation of Palm Springs and Desert Area, its volunteers, officers, directors, employees or any other agents or representatives from any claim of us, or our child, family, estate,

heirs or assigns arising out of my child's transportation by a Jewish Federation of Palm Springs and Desert Area employee while attending Camp Desert Star. We have completely and carefully read this Waiver and Release prior to freely and voluntarily signing our name below. We fully understand and agree to its contents.
